Warranty

Designers Fountain® warrants the structure of its products only against defects for one (1) year from date of invoice, and this warranty is ineffective against improper installation and usage or abnormal conditions. Designers Fountain® warrants for three (3) months products stored or used in extremely damp areas or areas under abnormal weather conditions, including but not limited to high winds, intense direct sunlight, and acid rain, where products may tend to tarnish easily. LED Products: LED fixtures have a limited Power Supply warranty (Module, PC Board Diodes and Drivers) of three (3) years from date of invoice.

Exceptions to this policy govern the warranty for our ceiling fans:

For Stellant (FP-STL52B30-xx) and Gallant (FP-GLT52B30-xx) models:

Designers Fountain limitedly warrants the fan motor to be free from defects in workmanship and material present for ten (10) years from date of purchase by the original purchaser. The manufacturer also warrants that all other fan parts, excluding glass or blades, to be free from defects in workmanship and material for a period of one (1) year. This warranty applies only to the original consumer purchaser and only to products used in normal use and service. If this product is found to be defective, the manufacturer's only obligation, and your exclusive remedy, is the repair or replacement of the product at the manufacturer's discretion, provided that the product has not been damaged through misuse, abuse, accident, modifications, alterations, neglect or mishandling.

For Astrea (FS-ATR52RGB-xx) and Cassini (FS-CSN52RGB-xx) models:

Designers Fountain limitedly warrants the fan motor to be free from defects in workmanship and material present for a ten (10) year period from date of purchase by the original purchaser. The manufacturer warrants the light kit, excluding any glass, to be free from defects in workmanship and material for a period of three (3) years from date of purchase. The manufacturer also warrants that all other fan parts, excluding glass or blades, to be free from defects in workmanship and material for a period of one (1) year. This

warranty applies only to the original consumer purchaser and only to products used in normal use and service. If this product is found to be defective, the manufacturer's only obligation, and your exclusive remedy, is the repair or replacement of the product at the manufacturer's discretion, provided that the product has not been damaged through misuse, abuse, accident, modifications, alterations, neglect or mishandling.
